MINUTES

The St. Martin Parish School Board convened on this day at 5:00 P.M. at the Breaux

The meeting was called to order by James Blanchard, President. Superintendent

Lavergne opened the meeting with a prayer and the pledge of allegiance.

An amendment to the motion was made by Mr. Fuselier and seconded by Mr. Foti to require the termination of the non-tenured grandfathered employees on a yearly basis. This action would then allow the non-tenured grandfathered employees whose contract was terminated the opportunity to re-apply for the position vacated. School administrators

(principals) would be afforded the opportunity to interview the retiree-rehire and other applicants meeting the certification requirements. Consideration for re-hire may be given to the retiree-rehire; however, a letter of recommendation for re-employment from the principal must be provided to the superintendent. At the end of each contract year, non-tenured grandfathered employees must be terminated. The amendment was then voted on and carried, as follows:
